A lapsing binding death benefit nomination is valid for up to three years from the day after it was first signed, or last confirmed or amended.

An existing lapsing binding death benefit nomination can be confirmed by you at any time in writing. The confirmation must be signed and dated but does not need to be witnessed.

If you have more than one account (e.g. you may also have a Aware Super super account) note that this renewal will only apply to the account details you have entered in **Section 1. Your personal details**.

You can amend an existing binding death benefit nomination by completing a new *Income stream death benefit nomination* form and sending it to Aware Super. This form is available on the Aware Super website and from customer service. You can cancel a binding death benefit nomination by completing and returning an *Income stream death benefit nomination cancellation* form.

We will write to you to acknowledge receipt of any nominations, confirmations or changes you make. If your nomination is invalid at the time of payment of a death benefit, the trustee will exercise its discretion in determining the beneficiaries of any death benefit.

You can only renew a current lapsing binding death benefit nomination. If your nomination has expired, you will have to complete a new *Income stream death benefit nomination* form. Your current nominated beneficiary(ies) and the expiry date of your nomination are shown on your last annual statement. If you have updated your nominated beneficiary(ies) since receiving your last statement, you can log in to your account online or call customer service to check the details.
