If we receive a switch request **before** the cut-off time on a business day, then:

- an account balance switch will take effect on that day
- a future contributions switch will take effect on the next business day.

If we receive a switch request **after** the cut-off time on a business day, then:

- an account balance switch will take effect on the next business day
- a future contributions switch will take effect on the business day after the next business day.

The cut-off time is 4 pm AEST/AEDT.

It may take a few days for your switch to be confirmed and visible in your online account.
