A lapsing binding death benefit nomination is valid for up to three years from the day after it was first signed, or last confirmed or amended. An existing lapsing binding death benefit nomination can be confirmed by you at any time in writing. The confirmation must be signed and dated but does not need to be witnessed.

This renewal only applies to the account shown in **Section 1 Your personal details***. If you have more than one account, you will need to complete a separate death benefit renewal form for each account. Other accounts could include additional super accounts, income stream accounts, or defined benefit (including deferred benefit) accounts. The appropriate forms are available on our website at aware.com.au/forms, and from customer service.

* If you are a Police Blue Ribbon Super or Ambulance Officers' Super member, this renewal will apply to your compulsory insurance account and any Police Blue Ribbon Super or Ambulance Officers' Super superannuation account you hold; you cannot have different nominations for each account. You can nominate either account number in Section 1 Your personal details.

Separate forms apply for income stream and defined benefit (including deferred benefit) accounts. All forms are located on our website at aware.com.au/forms.

You can amend an existing binding death benefit nomination by completing a new *Binding death benefit nomination* form and sending it to Aware Super. This form is available on the Aware Super website and from customer service. You can cancel a binding death benefit nomination by completing and returning a *Binding death benefit cancellation* form.

We will write to you to acknowledge receipt of any nominations, confirmations or changes you make. If your nomination is invalid at the time of payment of a death benefit, the trustee will exercise its discretion in determining the beneficiaries of any death benefit.

You can only renew a current lapsing binding death benefit nomination. If your nomination has expired, you will have to complete a new *Binding death benefit nomination* form. Your current nominated beneficiary(ies), and the expiry date of your nomination, are shown on your last annual statement. If you have updated your nominated beneficiary(ies) since receiving your last statement, you can login to your account online or call customer service to check the details.
